## TENDER FOR PROVISION OF FIBER OPTIC INTERNET SERVICES TO THE FEDERAL TAX OMBUDSMAN SECRETARIAT

Federal Tax Ombudsman Secretariat invites sealed tenders from well reputed Internet Service Providers (ISPs) for provision of high speed fiber optic internet services to Federal Tax Ombudsman Secretariat, HQ Islamabad and Regional Offices, located at Karachi, Quetta, Lahore and Peshawar.

2. The terms and conditions will be as follows:-

- Tender/offer shall be on the basis of single stage, two envelope bidding procedure (Technical Proposal & Financial Proposal) under PPRA Rule-36-B, one envelope containing information regarding “Technical solution” shall be clearly marked as “Technical Proposal”, Second envelope containing the priced offer shall be clearly marked as “Financial Proposal”
- Interested ISPs may obtain the tender documents containing complete technical information from 17-02-2016 to 06-03-2016 from the undersigned for a Non-Refundable tender cost of Rs.200/-, only on any working day.
- Tender / bid documents are to be submitted at the under mentioned address upto 07-03-2016 till 11:00 am. The envelope containing the “Technical Proposal” shall be opened on the same date at 11:30 a.m at the same place in the presence of those bidder(s) who wish to present.
- The second envelope of “Financial Proposal” shall be opened on a date to be scheduled / informed later i.e after evaluation of Technical Proposal(s).
- Earnest money equal to 5% of bid value calculated on yearly basis of quoted rates/price in the shape of pay order (original to be enclosed) in the name of Deputy Director (Admin) Federal Tax Ombudsman Secretariat may be attached with the “Financial Proposal”.
- Only those bidder (s) shall be allowed to participate who is/are authorized to provide internet services in the government sector.
- All the bidders will have to submit proof of NTN Registration and a certificate to the effect that the firm was never blacklisted.
- Partial and incomplete Tenders will not be considered. Tender received after the prescribed time and date or without earnest money, shall be rejected.
