FINDINGS/RECOMMENDATIONS

The above-mentioned complaint was filed under Section 10(1) of the Federal Tax Ombudsman Ordinance, 2000 (FTO Ordinance) against delay in disposal of refund application for Tax Years 2015 to 2021.

- 2. Briefly, the Complainant is an senior citizen, 89 years old, applied refund for Tax Years 2015 to 2021, but Deptt failed to process refund claims, hence this complaint.
- 3. The complaint was sent for comments to the Secretary, Revenue Division, in terms of Section 10(4) of the FTO Ordinance read with Section 9(1) of the Federal Ombudsmen Institutional Reforms Act, 2013. In response thereto, the Deptt submitted parawise comments vide letter dated 15.07.2022 contending that supporting documents for verification of tax payment were not provided, therefore notice u/s 170(4) of the Ordinance was issued requisitioning certain information from the Complainant for processing of refund.

- 5. DR heard and available record perused.

FINDINGS:

6. Perusal of the record reveals that Complainant is an 89 years old senior citizen, and he has applied for pending refund for the tax years 2015 to 2021.

RECOMMENDATION

(.No.24 -

FBR to:-

- direct the Chief Commissioner, RTO Lahore to help the a) Complainant in provision & furnishing of essential documents personal attendance of the complainant must be excused during refund proceedings;
- b) dispose of the refund claims for Tax Years 2015 to 2021 expeditiously preferably within 15 days in accordance with law:
- sanctioning of the due refund the 89 year old senior c) citizen must be telephonically informed and the due amount credited to his given account as a token of respect to the senior citizen; and
- d) report compliance within 30 days.
