## FINDINGS/RECOMMENDATIONS

Complaints has been filed under Section 10 (1) of the Federal Tax Ombudsman, Ordinance, 2000 (FTO Ordinance) regarding excessive deduction of withholding tax from salary of the complainant.

2. Facts of the case are that the Complainant is working as a Newscaster and employed by PTV, Peshawar. He has invited attention to this forum order in Complaint No.2538/ISB/IT/2021, whereby regular/adhoc/temporary/daily wages/hired are declared as different shades and forms of employment. Accordingly, low paid employees of PTV and PBC are given relief not to deduct income tax from their salaries. According to him, he is also employed under same

terms and conditions, therefore, not liable to pay income tax. He prayed to direct FBR/PTV to grant similar relief.

- 4. The Complaint was referred to Secretary Revenue Division for departmental reply/comments in terms of Section 10 (4) of the FTO Ordinance read with Section 9 (1) of the Federal Ombudsmen Institutional Reforms Act, 2013. In response thereto, the Chief Commissioner IR, RTO Peshawar vide letter No.654 dated 22.9.2023, reported that complainant did not provide relevant documents, substantiating his claim, which could be examined and commented upon under the law and relevant rules made thereunder.
- 5. Complainant did not attend. Mr. Muhammad Ashraf, DCIR, RTO, Peshawar (DR) attended on behalf of the Department. DR submitted that after perusal of the record in respect of compliance of earlier FTO's Findings/Recommendations in Complaint No. 0386 to 0402 & 0404 to 0424/Infml/2022 dated 01.09.2022, RTO, Peshawar has advised Principal Officer PTV, Peshawar vide RTO's letter C.No. CIR-DIK Zone/Misc/2022-23/710 dated 07.04.2023 to treat low paid employees as salaried individual and charge tax under Section 149 of the Ordinance.



## FINDINGS:

6. Complaints are filed against excessive and unjust practice of deducting income tax @ 10/20% under Section 153(1) (b) of Income Tax Ordinance (the Ordinance), from the salaries/wages of low paid temporary/contractual employees of PTV Centre, Peshawar Cantt, treating them as services providers. The complainants demand tax treatment under the head salary, warranting tax deduction u/s 149 of ITO, 2001. In dozens of cases of low paid employees of Pakistan Broadcasting Corporation (PBC), (complaint No.2538/ISB/IT/2021), the FBR's has implemented recommendation of FTO. Similarly in cases of hired lecturers and other employees of KPK's Education Department, this office has held that all these employees are governed u/s 149 of ITO 2001.

The Hon'ble President of Pakistan has also upheld FTOs recommendations in respect of the above mentioned low paid employees of KPK's education institutions.

7. This office has earlier issued detailed Findings / Recommendations in respect of low paid temporary/contractual employees of PTV Headquarter, Islamabad vide C.Nos.0386 to 0402 & 0404 to 0424/Infml/2022 dated 01.09.2022 and PTV, Peshawar vide C.No. 0844, 1600, 1601, 1602, 1603, 2406, 2407, 2408, 2410, 2411, 2412, 2415, 2418, 2419, 2420, 2421, 2422, 2423, 2424, 2426, 2427, 2431, 2432, 2446 & 2447/PWR/IT/2023 dated 11.05.2023 wherein it



has been established that the complainants, who have been hired by PTV as Supervisors, Translators etc. over the last few decades as low paid employees are entitled to the similar relief which has been allowed to the employees of PBC and other similar cases. Excessive and harsh deduction of tax from their meager salaries u/s 153(1)(b) of the Ordinance is against the dictates of law and nature of treatment being discriminatory, tantamount to maladministration in terms of section 2(3)(i)(b) of the FTO Ordinance, 2000. The instant twenty-nine (29) complaints filed by PTV Centre, Peshawar Cantt as tabulated in para 3 above also deserved the same treatment and their complaints are disposed of in same manner. RTO, Peshawar has also endorsed the treatment meted out in the parallel cases, referred above.

## RECOMMENDATIONS:

- FBR is directed to:
  - ensure that in line with parallel cases of PTV HQs, PTV, (i) Peshawar and PBC, the low paid employees of Pakistan Television Centre, Peshawar/Complainants are burdened with excessive tax deductions at withholding stage;
  - (ii) implement these recommendations & findings in liaison with PTV's Peshawar's management on the lines already done by the management PTV HQs and PBC HQs Islamabad; and
