#### "Every decision of FTO is a step towards a better Pakistan"

President Dr. Arif Alvi addressing an awareness seminar organized by FTO

n Awareness Seminar was organized by the Federal Tax Ombudsman at Governor House, Lahore on February 3, 2022. President Dr. Arif Alvi was the Chief Guest. While talking about providing facilities to the Taxpayers through awareness Seminar, he emphasized on increasing the Tax to GDP Ratio and said that we have been trying for the last 70 years to increase the Tax net but no tangible progress was still made. The President Dr. Arif Alvi urged the business and industrial community to come up with their own proposals for increasing the Tax net instead of presenting their demands to the government, as this is the most effective way to get the country out of financial problems. Let the people work together to increase the National income. The event was attended by a large number of Businessmen, Lawyers and Journalists from all over the province. Seminar coordinator Mr Joenda legal advisor to FTO said the Prime Minister has for the first time in the history of the country, has appointed an officer from FBR who understands all the nuances and difficulties in tax procedures . That is why, timely decisions are being issued. A detailed video about the performance of the Federal Tax Ombudsman was also released on this occasion. According to which, FTO office has issued decisions on about 14.000 applications since its inception 2000. Federal Tax Ombudsman Dr. Asif Mahmood Jah said that we also guarded our decisions through monitoring of implementation and facilitated payment of Refunds of Rs. 27 Billion to the Taxpayers trapped in FBR. This improved the atmosphere of harmony between the Taxpayers and the FBR. Federal Tax Ombudsman Dr. Asif Mahmood Jah, while welcoming the President Dr. Arif Alvi, said that he had assured the President and the Prime Minister of Pakistan that we will do our best to provide Justice in the country in accordance with the Laws and Rules of the country. He cited an



example of tractor imports case during the sowing season, As a large consignment of tractors was stopped by the Customs Officials despite all the payments and paperwork being completed, on which FTO spoke to the concerned Officers and the consignment was released within a few hours. He said that timely supply of tractors would have a positive impact on agricultural production. Federal Tax Ombudsman Dr. Asif Mahmood Jah said that this institution has been set up to solve the problems of the people. We are acting as Taxpayers' Advocate. And under Section 33 of the Federal Tax Ombudsman Ordinance 2000, disputes are being resolved in a matter of hours through mutual negotiations. He said that in order to promote tax culture in the country, we are creating an atmosphere of friendship with the Tax Payers . Taxpayers are being given confidence to believe that in case of any difficulty, there is an institution which can be approached free of cost. I also have a WatsApp number where people can send a complaint on a half page. We have also issued a special number on which a complaint can be lodged. FTO TV has also been launched for the awareness campaign.FTO Dr Asif Jah said four more Regional Secretariats in the country, and facility desks have also been set up at border check posts

of Balochistan and Khyber Pakhtunkhwa. I have also instructed my advisors to increase the liaison with the Taxpayers. For the first time, a Public-Private Partnership has been launched with the intention of improving the tax system. We are appointing honorary advisors from among traders, industrialists and investors. In this regard, names have also been sought from 46 chambers of Commerce and Industry. Appointments are being made on their recommendations. Atmosphere of cooperation will lead to increase in tax net inshallah.During his address, President Dr. Arif Alvi stated that he has expectation with the Federal Tax Ombudsman that he would solve problems of the Taxpayers in minimum time and keep them in the loop through awareness campaign. The FTO Offices will also try to reach out to as many people as possible through its awareness campaign. Speaking on the Islamic system of accountability, the President, referring to Hazrat Omar Farooq(Razi ALLAH Talaah Unhu ), said that the Islamic system of accountability is very simple and clear .When a man stood up and asked Hazrat Omar Faroog about his attire and how many pieces of cloth were used by him. He answered the question and said that his son's cloth was also used in it. He showed us how

accountability is to be conducted. However On the contrary, our accountability system suffers from legal considerations. The law is very simple, that is, whoever is the trustee of public wealth should answer for the use of public wealth. Instead of answering the question of accountability, people turn left and take advantage of the swing in the law.President Dr Arif Alvi directed the FTO to make positive progress and said that he would soon convene a meeting of Chairman FBR and Federal Tax Ombudsman. On the occasion, the President referred to the case of 82year-old retired pensioner Hamid Ali Khan. Instead of paying a refund of Rs 2333, the FBR had appealed to me the president against the FTO's decision.President Dr. Arif Alvi said that the organization of awareness seminar on Tax System by the Federal Tax Ombudsman is a very positive step. The public needs to know there is a Federal Tax Ombudsman. Referring to his previous politics, he said that reforms in the Tax System have been the focus of his attention in every era. "Every time a new Tax is imposed, the investment community comes to me. They want to avoid the new tax, adding

more people to the tax net will reduce the Tax burden per capita. If you read the newspapers of the fifties, you will also find stories of high taxes in those is very high. Another reason for tax fright is Whenever the government tries to impose a new Tax or takes steps to

the tax system. There is no exception for anyone in Islam. In Islamic times, Government lamps were burned during official work. Lamps would be extinguished as soon as it was finished. The son of the first Caliph used to say, "Mother, you feed us only one meal a

increase the Tax net, there is a noise of postponing it for 6 months because people do not want to come on the record. When we ask them why? only answer since the fifties is that people connected to the Tax System will harass us. That is why the federal government has not yet been able to impose an Agricultural Tax. Why? Whenever it is included in the Tax System, there will be trouble. I answer to everyone that you come to the system first and then demand that you pay more taxes and reduce taxes. There may be debate over whether the tax is higher or lower, but it is not appropriate to stay outside

day." This is the condition that the Head of State imposes on himself. We have so distorted this legacy that now an elderly Pensioner has filed a case for a refund of Rs. 2333. After serving the government all his life, he asked me to return Rs. 2333. The FBR demanded all the Bills that were given to him. The matter was dismissed there and then he went to the Federal Tax Ombudsman. He said, "Brother, bring it back." The Federal Tax Ombudsman ruled in favor of the elderly pensioner. But the FBR came to me instead of implementing. If you look at the performance here, if you have an employee and he keeps









cleaning the same glass all the month, then you will say that there are many more jobs, there are jobs worth millions of crores of Rupees, lying behind 2333

Rupees. This is the mill being run, how much did it cost? The time of FTO was wasted, the time of FBR officers was wasted, the time of the Presidency was also wasted. People should understand that they also have to serve the people.Addressing the Federal Tax Ombudsman, President Dr. Arif Alvi said that you decide in a few hours to 60 days but I read all the Files in one day and issue Orders. Today, I am in Lahore but I will receive the issues from the digital system and I will decide today. I have promised myself that I will issue the decision after reading the decision of each

ombudsman before the end of the night. I read all the files very carefully and there is no reason to delay them. Why should I rotate the file? This is what you said, people are taking money for tractors parked in clearance. When a shipment stops for ten days, people pay for it themselves. We have to end this culture. Delays in government work have to be eliminated. Where there is delay, there will be bribery. In the new digital system, decisions can be made in minutes. It will bring transparency. When it comes to Blockchain Systems around the world, things can't be changed. Papers can be lost or signatures cannot be changed. Recently, a decision came to me to



remove a NAB Employee. During a raid on the house of a corrupt Officer, 70 property papers worth billions of rupees were found. This corrupt person said that papers have been stolen from my system which caused loss of billions of rupees to the Government. You know, sometimes there is a fire in the office. sometimes there is a burglary, but there can be no such thing as a blockchain system. We will not harass anyone who pays as much tax as he earns. Withholding taxes and other indirect taxes are levied to determine how much revenue they will generate. People are ready to pay Taxes but they are nervous. Addressing the Federal Tax Ombudsman, Dr. Asif Mehmood Jah,

> the President said that you are also earning hereafter. Accountability to your Lord is the greatest accountability. Man does not steal because of 5 elements, first faith, second law and third being caught. The law is useless if someone is caught, the fourth is that those arrested should be punished. We saylet society decide that the thief is the thief. When you start forgiving thieves, my child will learn that money must come and no one will ask the source. But there will be no forgiveness before the Lord. Maybe Allah Almighty forgives in

return for a good deed but the real grip will be there. ## FTO Directs FBR to Revamp Training Programme

ederal Tax Ombudsman Hon'able Dr.Asif Mahmood Jah had urged tax department to revamp its training program to ensure professionalism. The Federal Board of Revenue (FBR) implements the recommendations of Federal Tax Ombudsman Dr. Muhammad Asif Jah, which are aimed at ensuring accountability and professionalism in the tax department's field formations.

The ombudsman had recommended that FBR should revamp its training program so that when experienced Officers of BS-18 are posted in Corporate Units, and Officials of BS-18 to BS-20 attend periodic capacity-building exercises at the Directorate of Training, their conduct should reflect the same.

Waheed Shahzad Butt, the lawyer who represented a case of maladministration and administrative excess before the FTO, said that they cannot rule out complicity and collusion of rogue FBR employees with criminal elements when the tax system is being routinely cheated.

The counsel said that the

FTO had proposed training and posting to build professionalism in Officers who have to deal with taxpayers.

Tax department neither wanted representation before President Dr. Arif Alvi, nor did it file any review plea before the FTO. The FBR has been avoiding the recommendations for a long time. The FTO had recommended that the Tax Department should review its career planning policy.

In the past, fresh DOT graduates were first attached with a senior Officer for a few months, then they were given some minor assignments, and were later posted in districts for further exposure and capacity-building. After four to five years of field experience, they were promoted to BS-18 and given major commercial assignments. Moreover, they were also given periodic capacity-building training. The FTO had ordered that the Tax Department revamp its training program, along with various modules, to ensure that when they are given field postings, their professional conduct reflects departmental attitude.

# President Alvi Concurs with FTO's Recommendation; Exchange Companies Declared Normal Banking For Remittances

resident Arif Alvi has confirmed Federal Tax Ombudsman decision that in MSBS (MONEY SERVICE BUSINESS) and MTO (MONEY TRANSFER OPERATOR) be considered by the FBR as Remittances through Normal Banking. State Bank Of Pakistan had clarified in 2019 that the foreign remittances received through MSBS/Exchange companies ,Foreign Remittances and MTO'S

also constituted "Foreign Exchange remitted from outside Pakistan through normal banking" .In a recent case decided by the President of Pakistan, the complainant a member of an AOP, e-filed returns of income for tax years 2017 and 2018 under section 114 (1) of the ordinance alongwith wealth and reconciliation statements by declaring foreign remittance amounting to Rs 1.645 million and Rs 2.290 million respectively. However, FBR issued notices to the complainant and kept the case pending for a long period without



any plausible reason. Subsequently, show cause notices were issued under the income tax ordinance proposing the addition of legally sent foreign remittances. The complainant requested Income Tax department to drop the proceedings in view of the state Bank of Pakistan (SBP's) clarification. The department, however, disregarding the legal position, facts, and case laws amended the assessments for tax years 2017 and 2018 and denied the benefit to the complainant. The complainant

therefore took up the matter with the Federal Tax Ombudsman.

Federal Tax Ombudsman directed FBR to issue circular to all the field formations to follow the clarification of the SBP and directed the commissioner -IR, Sialkot Zone to re-visit the order in the case of complainants in terms of section 122 A of the ordinance in the light of clarification issued by the SBP and Order-in-review by the FTO and pass fresh order after affording opportunity of

hearing to the complainant. However, instead of complying with the order FBR filed the review with the President of Pakistan.

The President has now affirmed the FTO's order and held that failure of FBR to follow SBP'S clarification is maladministration. He also decided that MSBS/EXCHANGE companies, MTOS be considered as normal banking for remittances and issued instructions to provide relief to the aggrieved taxpayers.

#### FTO Rescues a Lady Unduly Registered as Tier-1: Resolves the Complaint within 2 Days

petition was filed with the Federal Tax Ombudsman under Section 10(1) of the Federal Tax Ombudsman Ordinance, 2000 (FTO Ordinance), seeking exclusion of the complainants' case from "Tier-1-Retailers", under Sales Tax Act, 1990. The complainant was aggrieved on FBR's decision to include her in the said tier despite the fact that she had not conducted any business ever since her registration and that she has already notified it to the FBR.

It was observed by the FTO that the issue raised revolved around small technical hiccups, therefore, instead of resorting to formal investigation

proceedings under FTO Ordinance, 2000, provisions of Section 33 were invoked for instant resolution & relief. This section provides an alternate mode of redressal of the problems faced by the taxpayers. It reads;

33.Informal resolution of disputes.- (1) Notwithstanding anything contained in this Ordinance, the Federal Tax Ombudsman and authorized Staff Members shall have the authority to informally conciliate, amicably resolve, stipulate, settle or ameliorate any grievance without written memorandum and without the necessity of docketing any complaint or issuing any official

After authorization the matter, advisor Incharge, Regional Office, Lahore acting swiftly approached the concerned RTO to ascertain the factual position. In response the concerned tax authorities not only verified the veracity of complainant's claim, the case was excluded from Tier-1, Retailers on 25th January, 2022 by CIR-Zone-IV, RTO Lahore. Thus the genuine issue was resolved within 02 working days. The petitioner's lawyer confirmed that issue stands resolved and appreciated the quick & informal mechanism adopted by FTO Secretariat which bye-passes lengthy investigation proceedings.










### Upon FTO's Intervention, FBR Issues Instruction for **Expeditious Disposal of Income/Sales Tax Refunds**

onsequent upon the intervention of Federal Tax Ombudsman (FTO) Dr. Asif Mahmood Jah, Federal Board of Revenue (FBR) has issued instructions to its field offices for quick disposal of refund cases of income tax. The issue of unnecessary delay in processing these cases was taken up by the FTO with Member (IR) Operations, FBR. The instructions issued vide FBR's letter dated 04.02.2022 for early processing of income tax refund claims ordain FBR field offices to:-

- All CNIC/NTN based verifications available through system will be internally verified and verifications from other withholding agents will be carried out efficiently within the time limits provided under the law.
- No fresh audit / recovery proceedings will be initiated against the taxpayer during the period his complaint at FTO office is under process barring the cases where non-initiation of audit / recovery proceedings may have an element of time limitation or any other urgent requirement under the relevant laws.
- Refund claims involving FTO recommendations should be processed in light of already circulated SOPs so that these refund orders may be made available under FTO category in CITRO.

The above instructions will not only facilitate the taxpayers by doing away with the inordinate delays in refund claims in the name of lengthy verification procedures but will also be safe guarding the taxpayers against exploitation by way of unnecessary audit/recovery notices.

#### FTO Dr. Asif Jah Asks FBR to Fix **Specific Time Limit for Deciding ADRC Cases**

ederal tax ombudsman has held that failure of the FBR to pass any order on the ADRC's Recommendations dated 17.01.2008, as per Section 195-C(4) of the Act, constitutes maladministration and has recommended to chairman FBR to pass orders on ADRC's Recommendations dated 17.01.2008, in the case of M/s Gadoon Synthetic Mills Ltd as per law, FTO has also directed the Collector, Collectorate of Customs, Islamabad, to implement the subject order and

further recommended to FBR to make necessary changes in the Rules made under Section 195-C of the Customs Act 1969, giving a specific time limit by which, the Board may make orders upon the recommendations of the ADRC committee.

Briefly, the Complainant was engaged in the business of manufacturing of polypropylene yarn and was granted manufacturing bond license in July 1993, but was not renewed after 1995 which led to closure of the mill. The Complainant filed application dated 14.06.2006, for settlement of dispute through ADRC. Accordingly, FBR constituted a Committee and concluded the matter but no order was passed by FBR for the last so many years. The Complainant filed another application dated 05.07.2019, for implementation of ADRC's recommendations dated 17.01.2008, but failed to evoke any response. The Complainant, therefore, filed a complaint before this Office, which was rejected for want of jurisdiction as the matter was subjudice before the Hon'ble Islamabad High Court and Lahore High Court, Rawalpindi Bench. The Complainant filed representation against the FTO's Findings, before the Hon'ble President of Pakistan, who set aside FTO's Findings with the directions to

process, enquire and deal with the complaint in accordance with the law after affording due opportunity of hearing.

The proceedings were initiated afresh. During hearing, the Complainant stated that the application was filed before the ADRC in 2006, as per Section 195-C(4) of the Act, the FBR can pass an order as it deems appropriate, but no such orders were made and communicated to the Complainant. The Complainant stated that

> > implementation of ADRC's recommendations raised before this Office has not been challenged in **Customs Reference** No.2 & 9/2012.

The Secretary (Judicial), FBR/DR confirmed that no order under Section 195-C (4) of the Act was passed by the FBR. The Additional Collector, Collectorate of Customs, Islamabad/ DR stated that the Collectorate had already asked FBR, vide letter dated 22.10.2020, that Board may accede

to the request of the licensee to the extent of implementation of recommendations of ADRC dated 17.01.2008, however, the request for constitution of second ADRC being not only illegal but unreasonable may be declined. Two references before Hon'ble Islamabad High Court, Islamabad and Lahore High Court, Rawalpindi Bench, are although on the issue which has been taken up by the ADRC.

Hence FTO ordered that long standing grievance of the complaint may be attended. FTO also recommended that FBR may fix a specific time limit to decide such cases within reasonable timeframe in future.

#### Disposal of ADRC cases: FTO asks FBR to set

ISLAMABAD: The Federal Tax Ombudsman (FTO) has directed the Federal Board of Revenue (FBR) to fix specific time limit for deciding cases of Alternate Dispute Resolution Mechanism (ADRC).

In an order issued by the FTO office, the Federal Tax Ombudsman has held that failure of the FBR to pass any order on the ADRC's Recommendations dated 17 January 2008, as per Section 195-C(4) of the Act, constitutes maladministration and has recommended to the chairman FBR to pass orders on ADRC's Recommendations dated 17 January 2008. in the case of M/s Gadoon Synthetic Mills Ltd as per law.



#### Tax reforms crucial for economic development: Dr Arif Alvi

Dr. Arif Alvi said on Thursday that reforms in the tax system were crucial for economic development of the country.

Addressing an awareness seminar on tax system here at Governor's House, he said that tax-to-GDP ratio was very low in Pakistan which needed to be enhanced by restoring the confidence of taxpayers and facilitating people through the institution of Federal Tax Ombudsman.

In the past, a specific class evaded taxes through offshore companies and the money made through tax evasion was transferred to Swiss banks and Europe. These illegal practices put the country under heavy debt burden, he regretted. Contrary to this, he said that every citizen pays taxes in developed countries.

The president said that Imran Khan is the first prime minister who is making solid efforts to curb tax evasion and money laundering, adding that accountability is vital for a positive change in

In the Islamic history, the Khulfa-e-Rashideen [Rightly Guided Caliphs] presented themselves for accountability. He promised that maximum facilities would be provided to taxpayers.

Dr Arif Alvi said that tax collection system was backbone of any country's economy. "We need to create an atmosphere of trust in order to collect taxes from people. In this regard, the Federal Ombudsman and the FBR (Federal Board of Revenue) should put in joint efforts and play a key role in gaining people's trust and curbing corruption."

The president said that use of modern technology was unavoidable in today's world. It is a fact that people are reluctant to join tax net due to cumbersome documentation process in the institutions and they think that if they join the tax net, they will unnecessarily be bothered.

This fear needs to be allayed, which will require institutional reforms. He added that in developed countries, people do not have to travel to offices to get loans, join the tax net and pay taxes; that is why they pay taxes honestly. "We also have to adopt this model and convince people that their taxes will be spent for development of the country.

#### President upholds FTO decisions

The departmental plea regarding bar on jurisdiction of FTO in such cases has also been set aside by the president. He has directed The commissioner -IR Commission West ZONE ISLAMABAD and commissioner I-R Enforcement 11- CTO Karachi their orders by exercising powers conferred U/S 122 A ,as per law: and report compliance within 30 days.

In all three cases the background of the case was similar as under:

In the first case: pertaining to sahiwal against order framed under section 170(4) of the income Tax Ordinance, 2001 (the ordinance) for tax year 2018 by commissioner.I.R Sahiwal Mr Nazir Ahmad Proprietor of M/s Bilal Commission Shop.

In the second Case an individual filed return of income for tax year 2020 under section 114(1) of the ordinance claiming refund amounting to Rs 0.188 million and e-filed refund application for tax year 2020.

In case no 3, Mr. Yousuf irshad hussain,(the complainant) a propertie cocern, filed returns of income for tax years 2016 to 2019 under section 114 (1) of the income tax ordinance ,2001 the ordiance claiming refund amounting to rs 0.051 million ,Rs 0.048 million Rs 0.063 million and Rs 0.063 million and Rs 0.072 million. – **DNA**
